Veteran and Military Education Benefits Requests

All academic departments at the University of Dayton are approved by the State Approving Agency for Veterans' Training. All degree granting programs from last year's catalog are approved. If you interested in a brand new program, please contact us to inquire as to whether your major is approved yet for benefits. There is sometimes a delay between the creation of a new major and its approval for VA benefits. Any student who is requesting VA or DoD benefits is required to complete and sign all required forms, which can be obtained on our website and through the VA and DoD. Each semester, a request for VA benefits certification must be submitted through our website. The MVPS Center is available to assist you with this process. Students using VA and DoD benefits must inform us of any changes made to major, enrollment, or registration. Failure to follow this procedure may result in cancellation of benefits by the Department of Veterans Affairs. If a student on probation fails to acquire the required cumulative grade point average at the end of the next full-time term, the benefits may cease.

The University of Dayton adheres to all VA and DoD education benefits policies. Most of these can be found in the VA's School Certifying Official Handbook and the DoD's Voluntary Education Partnership Memorandum of Understanding ([dodmou.com](https://www.dodmou.com/) (<https://www.dodmou.com/>)). Service Members should contact their military Education Center before enrolling.
